

NOTICE OF THE DRAFT CONCENTRATED ANIMAL FEEDING OPERATION  
GENERAL PERMIT AUTHORIZATION NO. OKG011048

Pursuant to the Oklahoma Agriculture Pollutant Discharge Elimination System (AgPDES) Act and Oklahoma AgPDES Rules (OAC 35:44), notice is hereby given that the Oklahoma Department of Agriculture, Food, and Forestry (ODAFF), at the address listed below, has processed and issued a draft permit authorization including permit terms to Riverland Dairy, LLC, 1865 Private Road 1233, Hico, TX 76457, based on the notice of intent (NOI) submitted on December 30, 2024, for coverage under the Agricultural Pollutant Discharge Elimination System General Permit OKG010000 for Discharges from Concentrated Animal Feeding Operations (CAFOs). No discharge of pollutants into the waters of the state is authorized by this general permit except under a 25-year, 24-hour precipitation event or greater. All waste and/or wastewater will be beneficially used on agricultural land and/or transferred off site for beneficial reuse. Riverland Dairy operates a 5,300 total Mature Dairy Cows CAFO facility under the Standard Industrial Classification Code 0241. The Riverland Dairy is located in W/2 of Section 27, Township 8S, Range 10E, I.M.; Part of the E/2 of Section 28, Township 8S, Range 10E, I.M.; Section 33, Township 8S, Range 10E, I.M. excluding the SW/4 of the SW/4; NW/4 and most of the SW/4 of Section 34, Township 8S, Range 10E, I.M., Bryan County, Oklahoma.

The facility is located in the Middle Island Bayou Creek watershed (Waterbody ID No. OK410700000040\_00) in the Lower Red Region River Basin and in the Brown Creek watershed (Waterbody ID No. OK4107000000140\_00) in the Lower Red Region River Basin. The designated beneficial uses of the potential receiving water(s) are public and private water supplies, fish and wildlife propagation/warm water aquatic community, agriculture, primary body contact recreation, aesthetics, and fish consumption.
